Race Waiver for Above Specified Event

I understand that bicycles, skateboards, roller skates or blades, animals, and headsets of any type are not allowed in the race and I will abide by this guideline. Having read this waiver and knowing these facts and in consideration of your accepting my entry, I, for myself and anyone entitled to act on my behalf, waive and release the race timers, the city of Canfield, Canfield Fairgrounds, S & B Foundation, all sponsors, their representatives, employees, and successors from all claims or liabilities of any kind arising out of my participation in this event, even though that liability may arise out of negligence or carelessness on the part of the persons named in this waiver. I grant permission to all of the above mentioned parties to use my photographs, motion pictures, recordings or any other record of this event for any legitimate purpose.
